

# Churchill High School 2017-2018 Parking Contract

All motor vehicles parked anywhere on the Churchill High School campus must display a current CHS parking hang tag. Violators will be ticketed. Please be aware that students violating the parking contract and/or regulations may be ticketed, and may have parking privileges revoked at any time.

## Parking Regulations

- Hang tags are valid **only** on the vehicle listed on the parking contract.
- Hang tags are valid **only** when the entire permit is visible from the front of the vehicle.
- Vehicles must fit within the parking space as marked.
- There is **NO PARKING** in reserved spaces, yellow zones, fire lanes, driveways, landscaped areas, sidewalks, or spaces reserved for service vehicles.
- **The lack of available parking spaces is not an accepted excuse for not following parking regulations.**

## Driving Regulations

Within the campus boundaries and at all crosswalks, **pedestrians have the right-of-way**. The rules of the road and the laws applicable to operating motor vehicles in Oregon are equally applicable on the Churchill High School campus.

## Penalties for Parking Offenses on the Churchill High School Campus

These fines may be assessed if Churchill parking regulations are broken. Some parking violations may also be subject to city or state fines. Churchill's fees are as follows:

- Parking in a Handicap Parking Space without the appropriate permit (Violation of City/State Ordinance) - **\$100**
- Parking in a no-parking zone (Yellow School Bus Zone, Fire Zone, Loading Zone) - **\$50**
- No Parking Hang Tag, or Vehicle is Not Registered to the Displayed Tag - **\$25**
- Parked in a reserved space - **\$25**

**\*\*\*Fines are due and must be paid to the CHS Finance Office within 30 days of ticket date. \*\*\***  
(Please make checks payable to Churchill High School. Fines double after 30 days.)

## Safety Tips:

Churchill High School does not assume responsibility for any motor vehicle parked on campus, and is not liable for personal injury, property loss or damage. Drivers should always lock their cars and take their keys. Valuables should not be left in parked cars.

## Obtaining a Parking Permit:

Student hang tags are available for purchase at Fall Registration and in the CHS Finance Office all year. These tags allow for parking in any legal parking space on campus.

To obtain a parking hang tag, complete this contract and submit payment of \$50.00 per hang tag.
